The following Advisory Council is renewed and submitted according to Montana Code Annotated 2-15-122 guiding the creation of Advisory Councils by Agency Directors.

Council's Name and Agency

Labor-Management Advisory Council of the Department of Labor and Industry.

Council's Composition

The advisory council voting membership will consist of the Lieutenant Governor; five representatives of employers which include one member representing self-insurers and one member representing the Montana Chamber of Commerce; and five representatives of employees which include one member chosen by the Montana Trial Lawyers Association. The Employment Relations Division Administrator will serve as a non-voting member. The Lieutenant Governor will serve as chair of the advisory council. One person representing employers and one person representing employees will serve as co-chairs.

The advisory council may establish subcommittees upon a favorable vote.
