PER DIEM FEE

\$1,200 per day for hearing, research, and preparation. Time is prorated at eight hours per day.

GRIEVANCE ARBITRATION

\$1,200 per day for hearing, research, and preparation.

CANCELLATION POLICY

If the scheduled hearing is cancelled with at least 30 calendar days notice there is no cancellation fee. If the scheduled hearing is cancelled with less than 30 days notice, one-half of the per diem for each scheduled hearing day, but only if a replacement arbitration or mediation cannot be scheduled on the cancelled day(s). Still, using equity as a guide, the Arbitrator retains the sole discretion to waive a cancellation fee.

INT ARBT, FACT FND & LABOR MED

Interest arbitration, fact-finding, and mediation fees are charged at \$1,200 per day. Time is prorated.

TRAVEL TIME

Arbitrator charges per diem fee, prorated, not to exceed 8 hours per day.

EXPENSES

Arbitrator charges actual cost of reasonable expenses such as airfare, car rental, hotel room and taxi. Arbitrator does not charge for food and meals.
