Nelson let the board know that there will be a ULP Case for Review October 20, 2022.

Board Action – Case for Oral Argument (08:27):

Board Chair Brian Hopkins confirmed that all documents provided to the Board were reviewed by Board Members.

Alan Zackheim representing the (respondent) Department of Public Health and Human Services (DPHHS) presented his oral argument. DPHHS argued that it filed objections to preserve the issues for appeal, but DPHHS would be satisfied with the Board adopting the Hearing Officers Findings and Conclusions in full. DPHHS consider the conclusions of the Hearing Officer to be both reasonable and equitable. DPHHS argument in this case matter is when to start the clock on back pay.

Lin Deola representing the petitioner(s) presented her oral argument in this case matter. Deola argues that there was never a legal basis identified and therefore no rationale on the date of which back pay should begin. Deola states the finding is that the disparity started in 2005 and back pay should be granted on this date.
