2025 FEE SCHEDULE (PD increases one-hundred dollars each January 1)

Arbitration Per Diem: \$2,900. Mediation/Interest Per Diem: \$3,300. PD charged for any portion of a day up to seven hours; pro rata after seven hours and for conference, study, and writing. If a matter is canceled or postponed with notice of 30 or fewer days, PD charged for each day set unless parties substitute a like matter. Travel time (one-way): No charge for under two hours; half PD for over two hours; PD for over four hours. Reasonable expenses charged.
