

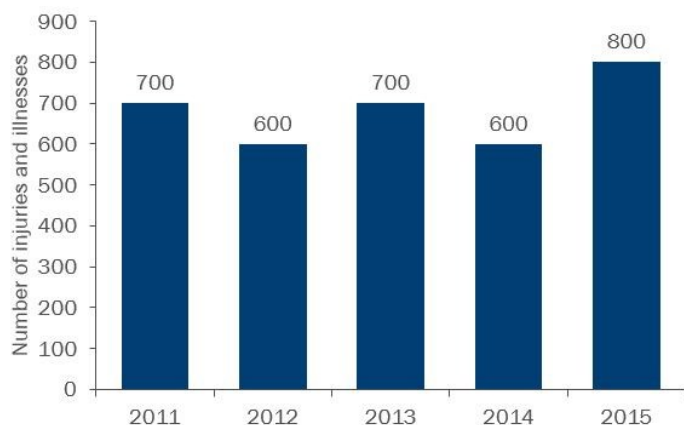
TRANSPORTATION AND WAREHOUSING

The Transportation and Warehousing Industry sector (NAICS code 48-49) includes establishments that provide transportation of passengers and cargo, warehousing and storage for goods, scenic and sightseeing transportation, and transportation support activities. Modes of transportation include air, rail, water, road, and pipeline. In 2015, there were 12,075 total employees and 1,499 total establishments in the private Transportation and Warehousing industry in Montana. There were 2,021 federal government employees and 498 local government employees in this industry in 2015. General freight trucking (25%) and specialized freight trucking (20%) in private industry employed the most workers in Montana in 2015.

Number of Work-Related Injuries & Illnesses

In 2015, an estimated **800** non-fatal injuries and illnesses occurred in Montana's private Transportation and Warehousing industry.

Rate of Work-Related Injuries and Illnesses

In 2015, there were **5.7** estimated cases of non-fatal injuries and illnesses per 100 full-time workers in Montana's private Transportation and Warehousing industry, which was higher than the national rate of 4.5 cases per 100 full-time workers for this industry.

Work-Related Injury and Illness Facts

Of **300** total injuries involving days away from work:

- 80% of injuries were men
- 40% of injuries were workers aged 55-64
- 50% injuries occurred in heavy and tractor-trailer truck drivers
- 23 days: median number of days away from work
- 23% of injuries involved the cranial region of the head, including the skull
- 40% of injuries were sprains, strains, or tears
- 20% of injuries were jack-knifed or overturned vehicle events on roadways
- 27% of injuries involved semi, tractor-trailer, and tanker trucks

Work-Related Fatal Injury Facts

From 2011 to 2015, there were **18** work-related fatalities in Montana's Transportation and Warehousing industry.

- **12** fatalities due to transportation incidents

In 2015: **1** work-related fatality in this industry, due to a transportation incident.
