This report details Montana workplace fatalities that occurred in 2023 due to traumatic injuries. Fatality statistics are used to fulfill a commitment to bring awareness and education to increase worker safety.

The information detailed in this report is gathered by the Employment Standards Division, Montana Department of Labor & Industry, in cooperation with the Bureau of Labor Statistics, U.S. Department of Labor.

The CFOI program utilizes a wide variety of data sources, including Occupational Safety and Health Administration (OSHA) reports, workers' compensation records, vital records, coroner's reports, media reports, and police reports of vehicle crashes.


In Montana in 2023, there were 38 work-related fatalities.

Over half of the employees fatally injured were wage and salary workers, accounting for 24 of the 38 incidents. Fourteen self-employed workers made up the remaining cases.

The leading cause of fatal occupational injuries in 2023 was transportation incidents accounting for 13 deaths. Contact incidents accounted for ten fatalities and exposure to harmful substances saw five.

Major occupation groups showed both transportation and material moving occupations and farming, fishing, and forestry occupations experienced seven fatal injuries each. Farmer, rancher, agriculture manager occupations had six fatal incidents. Construction and extraction occupations accounted for four fatal injuries.


Fatal injuries were highest among workers 65 years and older workers with eleven fatalities. 55 to 64 years category had nine, and 45 to 54 years had six fatal incidents.



The following chart shows Montana's number of occupational fatalities per year over the last ten years.


Industry

Industry identifies the industry the decedent worked in, as described by the North American Industry Classification System (NAICS).




Occupation

Worker occupation describes the occupation the worker was engaged in at the time of the fatal incident or exposure as described by the Standard Occupational Classification system.



Event

The event or exposure describes the manner in which the injury or illness was produced or inflicted.



Work Status


The status indicates the classification of someone employed as either an employee or self-employed



Age

The age of the decedent at the time of the fatal injury or exposure.

Totals include fatality data not meeting publication criteria due to confidentiality.
