CEC Reminders!

1. If you are certified, you already have an online account.

- * Please email me if you can't remember your login credentials and I will reset and/or activate your account.

2. Please check with me PRIOR to taking any online trainings

- * I'm seeing a lot of trainings that are not approvable for CE's pertaining to the WC Certification program.

3. Make sure you are updating any changes in your account

- * Employer changes, email changes, name changes, must be done within 20 days.

4. Renewals are not automatic

- * You will receive a reminder email about your upcoming renewal 3 months prior to your renewal date. It will also send you a copy of your CE total. Please pay attention to these, so you know if you need to complete any required credits before renewing.

- * Reach out to me if you need help finding trainings.

2. Click on your blue certification link (this is your new certification link).
